#### Direct Ship Orders-Available until November 12

Direct Ship orders are available through M2 for Girl Scouts making a few more sales to meet their goal, or to help a troop reach their proceeds goal! It's important to note that the shipping costs for nuts and candies will be higher than other items due to the need to ship them overnight and on ice, but the BarkBox has a flat rate shipping cost – even to Alaska. Magazine prices also include mailing, and some are available right away digitally! These are great options for Girl Scouts wanting to make a few more sales in November.
