EVENTS INCLUDE FIELD TRIPS, COMMUNITY AND ENVIRONMENTAL SERVICE PROJECTS, AND EDUCATIONAL PROGRAMS SUCH AS STEM (SCIENCE, TECHNOLOGY, ENGINEERING, MATHEMATICS) PROGRAMS. THE COOKIE AND NUT & CANDY PROGRAMS TEACH GIRLS BUSINESS SKILLS INCLUDING GOAL-SETTING, PUBLIC SPEAKING, AND MONEY MANAGEMENT. THE COOKIE PROGRAM ALLOWS GIRLS, TROOPS, AND SERVICE UNITS TO EARN RECOGNITION AND REWARDS THAT THEY CAN USE TO PAY FOR GIRL SCOUT PROGRAMS OR CAMPS. 1,032 GIRLS PARTICIPATED IN THE COOKIE PROGRAM AND 227 GIRLS PARTICIPATED IN THE NUT & CANDY PROGRAM.
