

Cookie Credits/Fall Product Program Credits:

Girl Scouts of Alaska Cookie Credit Policy – Updated December 1, 2021

Girls work hard to set goals, sell cookies, and earn their rewards. Girl Scouts of Alaska wants to make sure girls have a chance to experience the rewards they worked so hard to earn. The cookie credit policies have been revised so that girls will be able to use their credits when they feel safe to do so and camp is available to them. For 2022, Girls can use their cookie credits and Fall Product Program (FPP) credits in the following ways:

At Camp in 2022

- Credits from the 2019, 2020, and 2021 FPP as well as the 2020, 2021, and 2022 Cookie Program can be used for Girl Scouts of Alaska Camps in summer 2022.
- Any unused 2019 and 2020 FPP credits and 2020 and 2021 cookie credits will expire on 9/30/2022.
- Unused 2021 FPP credits and 2022 Cookie credits will carry over and expire on 9/30/2023

- Girls can use cookie credits for camp in the following way
 - Day Camp:
 - \$0.20/box
 - 450 boxes = free camp week
 - Resident Camp:
 - \$0.35/box
 - 450 boxes = free 3-day camp session
 - 650 boxes = free 6-day camp session

More Ways to Use Credits through the 2022 and 2023 Membership Year

- Girls may use FPP or Cookie Credits for Girl Scout membership for themselves or others, including lifetime memberships for graduating seniors.

- Girls can share their credits and help another girl get to GSAK Camp.
- Girls may also use their credits for programs and events held by Girl Scouts of Alaska or share their credits with another girl for GSAK programs.

The oldest credits will be applied first in order for girls to maximize their use of credits.

Camp Credits

We are planning to run in-person day camps in all regular locations for 2022 and overnight camp at Camp Togowoods. In the case that does not happen, we will revisit our Cookie Credit policies and credit expiration dates.

Encampment Credits

Encampment credits are troop, not individual credits. Girls do not use their camp cookie credits to pay for encampment. We are planning on holding encampment in early June 2022. If we are not able to hold in-person encampment, we will revisit encampment credit policies and expiration dates.

- \$0.15/box for troops on the road system
- \$0.20/box for troops off the road system
