THE ORGANIZATION RUNS PROGRAMS, CAMPS, EVENTS, FUNDRAISING ACTIVITIES, AND MEMBERSHIP ACTIVITIES FOR GIRL SCOUTS IN SOUTHWEST, SOUTHEAST, AND SOUTHCENTRAL ALASKA.

EVENTS ARE TYPICALLY ONE-DAY PROGRAMS REVOLVING AROUND A TOPIC IN WHICH GIRLS ARE INTERESTED. EVENTS INCLUDE FIELD TRIPS, COMMUNITY AND ENVIRONMENTAL SERVICE PROJECTS, AND EDUCATIONAL PROGRAMS SUCH AS STEM (SCIENCE, TECHNOLOGY, ENGINEERING, MATHEMATICS) PROGRAMS. THE COOKIE AND NUT & CANDY PROGRAMS TEACH GIRLS BUSINESS SKILLS INCLUDING GOAL-SETTING, PUBLIC SPEAKING, AND MONEY MANAGEMENT. THE COOKIE PROGRAM ALLOWS GIRLS, TROOPS, AND SERVICE UNITS TO EARN RECOGNITION AND REWARDS THAT THEY CAN USE TO PAY FOR GIRL SCOUT PROGRAMS OR CAMPS.

4b (Code: ) (Expenses \$ 504,155. including grants of \$ 17,430. ) (Revenue \$ 12,292. ) RECRUITMENT: GIRL SCOUTS OF ALASKA SERVED ALMOST 1600 GIRLS WITH OVER 2600 VOLUNTEERS. GIRLS JOIN TROOPS OR JOIN AS INDEPENDENTLY REGISTERED GIRLS. THEY ATTEND PROGRAMS, EARN BADGES, GO TO CAMP, AND PARTICIPATE IN THE COOKIE AND NUT PROGRAM. VOLUNTEERS LEAD THE TROOPS, AND COUNCIL STAFF COORDINATE PROGRAMS AND CAMP, COACH VOLUNTEERS, RECRUIT GIRLS AND VOLUNTEERS, AND MAINTAIN CAMP FACILITIES.

IN THE SUMMER OF 2021, GIRL SCOUTS OF ALASKA PROVIDED DAY CAMP AT CAMP SINGING HILLS AND OVERNIGHT CAMP WAS CANCELLED DUE TO THE PANDEMIC. GIRL SCOUTS OF ALASKA TYPICALLY HOSTS DAY CAMPS ACROSS SOUTHWEST AND SOUTHEAST ALASKA, BUT DUE TO THE PANDEMIC WERE UNABLE TO HOST IN SOUTHWEST ALASKA AND SEVERAL COMMUNITIES IN SOUTHCENTRAL AND SOUTHEAST. GIRL SCOUTS OF ALASKA WAS ABLE TO HOLD CAMP FOR SEVERAL WEEKS IN JUNEAU.
