

2021-2022 Destination Credits FAQs

What are Destination Credits?

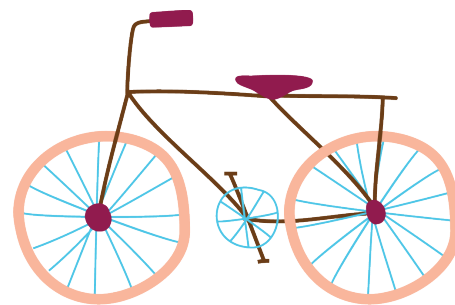
Destination Credits are a way for Girl Scouts to earn credits specifically for [Destination](#) travel. For every box of cookies sold, credit is earned (see scale of credits on pg 2). Destination Credits are earned by an individual girl. If receiving Destination Credits for an approved trip, girls will not receive cookie incentives. Destination Credits have no cash value and are redeemable during the current Girl Scout membership year.

Who is eligible for Destination Credits?

Cadette or older Girl Scouts who have been accepted on a Destination trip.

What do Destination Credits cover?

Destination Credits can only be used to cover girl expenses. Girl expenses include event fees, airfare, and accommodations during the event. Destination Credits cannot be used for individual spending money.



When should I apply for Destination Credits?

You should apply in the same membership year as your trip, after you have been accepted on the Destination. For example, if you are traveling to Belize in June 2022, you should apply for Destination Credits between October 1, 2021 and February 1, 2022. If you apply for your Destination in 2022, but are not traveling until 2023, you'll apply for Destination Credits between October 1, 2022 and February 2023.

How do I apply for Destination Credits?

A parent/guardian will need to submit the Application for [Troop Trip Cookie Credits/Destination Credits](#) between October 1, 2021 and February 1, 2022. An application must be completely filled out to be accepted. Applications will be reviewed to ensure that all information is included and the trip meets the appropriate qualifications.

Do girls who receive Destination Credits also earn their normal cookie proceeds, rewards, or camp credits?

No, girls will not receive any proceeds, incentives/rewards, or camp credits if they elect to receive Destination Credits. Girls who receive Destination Credits must sell as an independent Girl Scout and will be listed separate from their troop in eBudde. Their sales will not count towards total troop sales.

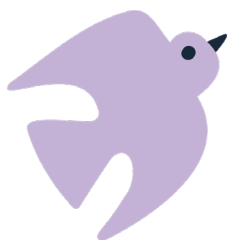


How do girls receive Destination Credits?

In order for girls to receive their Destination Credits, documentation of expenses (receipts for airfare, event fee or accommodations, statement or bill from event sponsor) will need to be turned in to Girl Scouts of Alaska. GSAK will reimburse the fees to the payer and/or pay vendors directly.

Can girls apply for Destination Credits two consecutive years (i.e. 2022 and 2023)?

Yes, all Cadette, Senior, and Ambassador Girl Scouts may apply 2 years in a row. If Council receives more applications than allotted spots, then a lottery will be conducted. Priority will be given to girls who have not received Destination Credits before.
