### Fall Product Program News

Last day for Girl Scouts to deliver their Fall Product Orders  
November 27 is the last day for Girl Scouts to deliver their Fall Product Orders. We know that some girls will be making deliveries to family members over the winter holidays, but with the official end to the program girls and troops need to wrap up financials. Talk to your families about getting their owed money in before the ACH on

**Fall Product ACH**  
If your troop owes council money for Fall Product sold, we will do an ACH sweep on December 1 for the amount owed. This means council will automatically pull the money from your troop bank account. Please make sure that your troop has the necessary funds in their account before that date. All troop proceeds will remain in your account.

If your troop had mostly or entirely online transactions, council may owe you troop proceeds! If we owe you, we will automatically push that amount into your account later in December.

**Fall Product Troop Proceeds**  
If your troop sold Fall Product mostly or entirely online, council may owe you back troop proceeds. If that is the case, we will direct deposit your funds on December 15 or 18 (we complete the process on the 15, sometimes the receiving banks take an extra day to complete the process).
