Booths Available for Sign-up!

If your troop cannot attend a cookie booth that you signed up for, please release the booth in eBudde! This takes the booth off of the cookie finder so the public isn't expecting to see Girl Scouts at that time and location. You can release a council booth up to one minute before the booth begins! As troops release booths, they immediately become available to all troops. If your favorite location was taken, check again because it may be open now!

Customers interested in cookie ingredients? All Girl Scout Cookies are produced by our trusted licensed bakers, who are leaders in their industry. Cookies are made with ingredients that adhere to rigorous food safety standards set by the U.S. Food and Drug Administration (FDA) and other relevant authorities. Troop Site Setup

Digital Cookie Troop Site set up began February 1. Please set up your troop site if you have not done so already. <u>Remember, troop sites must be set up before</u> you can use them to process credit cards at cookie booths.

Troop Booths

Don't forget, any cookie booth secured by a troop must be entered into eBudde as a troop booth! This allows us to advertise your booth to the public, as well as ensures that your booth is covered by our insurance.

Cookie Dough

This is a reward that needs to be chosen at final rewards selection, it is not accumulated automatically. Find more information on our website.

Girl Orders tab


